SECTION 6: SPECIAL CONDITIONS OF CONTRACT

The special conditions of contract shall be read in conjunction with Schedule of rates, scope of work and any other document forming part of contract, wherever Context so requires. In case of any contradictions the Decision of the Engineer-I In-Charge will be final and binding on the Contractor. In case of contradiction between Indian or other applicable Standards, Special Conditions of Contract, Specifications, drawings, Schedule of Rates, the following shall prevail in order of precedence:

- i) Letter of acceptance along with statement of Agreed variations.
- ii) Fax / Letter of Intent / Fax of Acceptance
- iii) Schedule of Rates as enclosures to letter of acceptance
- iv) Job / Particular Specifications
- v) Technical / Material Specifications
- vi) Special Conditions of Contract.

It will be contractor's responsibility to bring to the notice of Engineer-in-charge any irreconcilable conflict in the contract documents before starting the work(s) of making the supply with reference which the conflict exists.

1) Delivery Period:

Duration of this contract for complete execution of job shall be 2 weeks from date of issue of Purchase order for the supply of Natural Gas Leak Detector with CH₄ LEL Sensor at Hyderabad, Vijayawada & Kakinada Gas.

2) LOCATION/SITE INFORMATION: Delivery Address shall be intimated by EIC.

3) PAYMENT TERMS:

The Payment shall be made in the following manner subject to completion of all contractual requirements as per tender document.

- ➤ 100 % (Hundred percent) payment of the supplied portion including taxes & duties will be paid on receipt & acceptance of goods at FOT site after adjustment of PRS, if any along with submission of following documents:
 - i) Original Invoice in triplicate in compliance with GST law in force
 - ii) Inspection Release note by Owner or his appointed or approved agency.
 - iii) Original GR / LR
 - iv) Packing List
 - v) Insurance cover note covering transit insurance
- ➤ PACKING & FORWARDING : Included
- > FREIGHT : Included

4) CONTRACT PERFORMANCE SECURITY: Not applicable.

5) CONTRACT PRICE:

The Quoted prices shall be deemed to be inclusive of all taxes including works contract tax, duties, GST tax, and other charges as applicable till the completion of the contract and contractor shall not be eligible for any compensation on this account.

Bidder must quote of full quantity against each quoted item mentioned in the Schedule of Rates of tender document; otherwise, bidder's offer will be liable for rejection.

6) PROGRESS OF WORK:

The Contractor shall proceed with the Work under the Contract with due expedition and without delay. The EIC may direct in what order and at what time the various stages or parts of the work under the Contract shall be performed. If the Contractor can reasonably comply with this direction, the Contractor shall do so. If the Contractor cannot reasonably comply, the Contractor shall notify the EIC in writing giving reasons.

7) CONTRACT VALUE: -

The value of work under this contract shall be as per quantities mentioned in the SOR. Actual work may vary to any extent plus or minus to the attached quantities and the contractor must do so as per BGL's requirement.

8) TERMINATION

If in the opinion of Engineer-In-Charge the performance of Party is not found satisfactory, the contract will be terminated by giving 15 (Fifteen) days' notice. Any loss incurred by the Company on this account shall be recovered from the Party. BGL shall also have the right to complete pending jobs under this contract by engaging any other agency at the risk and cost of original Party.

9) DEFECT LIABILITY PERIOD for services: Nil

10) Guaranty/Warranty:

- a) The Manufacturer standard warranty for the period of 2 years against the faulty goods or workmanship from the date of receipts of Goods.
- b) The Consumable parts are not included in the warranty.
- c) The warranty covers monitor assembly, power supply, and sensors.

11) Equipment Specifications

All the equipment, components and material enumerated under the 'Scope of Supply' would be as per OEM design recommendations. \
